



# RINK REGULATIONS

**Below, we present a few rules and regulations that we have introduced to ensure the common safety of both our guests and employees. Please familiarize yourself with the following regulations before entering.**

1. The ice rink is owned by Piruet Sp. z o.o. headquartered in Warsaw at ul. Lanciego 10b/12 and is administered by the company.
2. The ice rink is open from Monday through Sunday, with scheduled sessions and maintenance breaks.
3. In case of unfavorable weather conditions (such as heavy snowfall or gusty wind), the ice rink may be temporarily closed.
4. A maximum of 40 people can be on the ice rink at the same time.
5. The administrator may temporarily restrict access to the ice rink due to exceeding the maximum number of users or if the number of people poses a safety risk.
6. Use of the ice rink is at your own risk. Skaters assume the risks associated with amateur skating.
7. In the case of events and sports shows, the administrator reserves the right to change the schedule of the ice rink use.
8. Children under the age of 7 can only use the ice rink under adult supervision.
9. Gloves and protective helmets are recommended, especially for children under 10.
10. Everyone using the ice rink must follow the instructions of the cleaning staff and adhere to the announcements made through the speakers.
11. Please maintain maximum caution while on the ice rink.
12. You may skate on the ice rink only in the specified direction, and a change of direction is signaled by the rink staff.
13. Skates can only be on the ice rink surface and mats or in other designated areas.
14. Any perceived damage (e.g., damage to the ice surface or equipment), accidents (involving ice rink users), or irregularities should be reported to the ice rink staff immediately.
15. People using the ice rink are not allowed to:
  - use speed skates, hockey sticks, hockey pucks, and other items that may pose a threat to participants using the ice rink;
  - sit on the barriers surrounding the ice rink;
  - throw snow;
  - skate while carrying children;
  - bring or consume drinks and food on the ice rink surface;
  - damage equipment or devices;
  - skate against the flow, organize races, or engage in dangerous games;
  - walk on the ice rink surface in regular shoes.
16. The following are forbidden in the ice rink premises:
  - bringing and consuming alcoholic beverages;
  - staying on the premises under the influence of alcohol;
  - smoking cigarettes.
17. The administrator is not responsible for items left at the ice rink.
18. The administrator is not responsible for damage to valuable equipment brought to the ice rink (e.g., mobile phones).
19. Individuals not following the regulations will be asked to leave the ice rink without the right to a refund.
20. Individuals consistently violating the regulations will not be allowed at the ice rink.
21. Everyone using the ice rink is obliged to familiarize themselves with the above regulations and adhere to these principles.

23. A first aid kit is located in a marked container at the ice rink counter.
24. It is assumed that every person, before purchasing an entrance ticket, has read the provisions of the regulations and has committed to its unconditional compliance.
